Public comment shall be concise and to the point and shall not contain abusive, defamatory, or obscene language.

## 2021 BUDGET ADOPTION

The 2021 budget has been updated since the introduced version last month and can be found on page 4. The most significant change is the Stop Loss line.

**Stop Loss** – The Stop Loss Renewal was received and was lower than anticipated. A formal RFP was not performed. The following details are included:

## STOP LOSS RESOLUTION

Resolution 22-20 includes binding of the Stop Loss policy with the terms and conditions described in the budget presentation.

## **ONSITE HEALTH CENTER - RFP DECISION**

Responses to the Fund's RFP for the Administrator of the Onsite Health Center were received in July 2020. Two vendors responded – Integrity Health (incumbent) and R-Health. In early October, a

subcommittee of the HIF interviewed both vendors. The Fund was instructed to obtain 'best or final' pricing from each.

## Results:

R-health - committed to the financial terms and conditions in its original proposal

## **Integrity Health**

- Reduced management fee from \$31 pepm to \$27 pepm.
- Absorbed certain pass through expenses in within this fee
- Capped health care salaries and benefits
- Total decrease ~8% from original proposal

Based off the qualifications and final financial proposals of both respondents, it is the recommendation of the Executive Director/Program Manager that the Fund award the contract to the incumbent, Integrity Health effective April 1, 2021 through March 31, 2024. Below is a recommended evaluation.

## **EUS CERTIFICATIONS**

For State filing and regulatory purposes, there are 2 EUS (Extraordinary Unspecified Services) Certifications for Aetna and United Healthcare Medicare Advantage that are required to be approved by the Fund. The certifications along with Resolution 24-20 are included in the consent agenda.

## DIRECT BILL COUPONS - RETIREES AND COBRA

Benefits Express requires at least 60 days to guarantee updated direct bill retiree coupons and ACH debits by January 1. Since the budget is just being adopted, that timeframe cannot be met. PERMA will work diligently with BE to determine when these coupons will be mailed and the recommended payment process. We will work with each of the entities on a communication strategy to the impacted retirees.

## **OPEN PUBLIC MEETINGS ACT - REMOTE MEETING CHANGES**

There were some updates the Open Public Meetings act to consider for Zoom meetings. The following changes will be made effective the next public meeting. The Fund Attorney has reviewed and approves. Resolution 25-20 formalizes these changes.

- 1. Adopt via a resolution standard procedures and requirements for public comment (included in consent)
- 2. Prepare standard notice of meeting which is to contain clear & concise instructions for public access to the meeting, how to submit public comment and where the agenda/meeting documents can be found
- 3. Revise the annual meeting notice to state that due to the Governor's State of Emergency Declaration that meetings will be conducted as remote meetings until further notice;
- 4. Post copies of each meeting notice and the revised annual meeting notice on the Fund's website and on the door to the main public entrance of the municipality where the in person meeting would have been held & on the main handicapped access door;
- 5. Have a link on the meeting notice or on the Fund website near where the meeting notice is posted for the download of the meeting agenda by the public;
- 6. Prepare a standard form of announcement to be read at the beginning of each remote meeting that adequate & electronic notice of the remote meeting was provided, stating the time, place and manner in which the notice was provided.

## **AETNA UPDATE**

## Network Update

Network negotiations with Premier Health were held over the past few months. Approximately 18 Fund members received letters in late July notifying them that Premier Health was going to pull out of the Aetna network on 9/1/2020. We are pleased to announce that the negotiations were successful and Premier Health remains in-network with Aetna. Impacted members received retraction letters.

## UNITEDHEALTHCARE UPDATE

**Retiree Mailing-** UnitedHealthcare is reaching out to retirees enrolled in UHC Medicare Advantage Plans to update their contact information. In an effort to increase member engagement in clinical programs, such as *HouseCalls* and *Just Checking In* the attached letter is being mailed to retirees who do not have a phone number or email registered to their account.

**Medicare Advantage ID Cards –** We have been advised that UHC issues new ID cards *every year* to Medicare Advantage members. New cards with a January 1, 2021 effective date are being mailed to **all SSRHIF retirees** enrolled in a UHC Medicare Advantage plan. Please note that <u>there are no</u> <u>changes to benefits or ID numbers</u>.

## **COMPLIANCE UPDATE**

**Annual NOCC Mailing –** As in previous years, ESI has mailed the annual Notice of Creditable Coverage to all plan members (active and retirees) who are currently age 65 or older, or will be reaching age 65 in 2021. A sample of the NOCC that was mailed in early October, is included with your agenda.

## LEGISLATIVE UPDATES NJ COVID Executive Orders

- 1. Executive Order #172 As you may be aware, NJ Governor Murphy recently signed Executive Order #172, which allows entities in the State Health Benefit Plan (SHBP) to waive the normal waiting period for new hires, enabling them to enroll in health benefits upon date of hire. The order became effective on 8/3/2020 and will remain in effect for the duration of the COVID-19 NJ Public Health Emergency. Fund entities wishing to comply with this order may do so by completing and returning the Plan Document Amendment form included with this agenda to PERMA. We strongly recommend that the amendment, be ratified by the entity's governing body.
- 2. Executive Order #192- On October 27, 2020, Governor Phil Murphy signed Executive Order #192 which requires all New Jersey public and private employers institute mandatory health and safety protocols to protect workers and their families from COVID-19 exposures. The Executive Order also directs NJDOL to provide compliance and safety training for employers and employees. For more information, please review the attached brief from the MEL JIF.

## NJ Health Benefit Mandates

- 1. **NJ Senate Bill #2133** Earlier this year, NJ Senate bill 2133 expanded the NJ Infertility Mandate as follows:
  - Requires coverage for *standard fertility preservation services* when a medically necessary treatment directly or indirectly causes *iatrogenic infertility*.
    - *Iatrogenic infertility-* impairment of fertility caused by surgery, radiation, chemotherapy, or other medical treatment.
    - Standard fertility preservation services -procedures consistent with established medical practices and professional guidelines published by the American Society for Reproductive Medicine, The American Society of Clinical Oncology, or as defined by the New Jersey Department of Health.

We will be working with the Risk Manager of each member entity to determine coverage.

**2. NJ Assembly Bill 5508-** In 2020, NJ passed legislation that adds coverage for male sterilization at 100% for ACA and non-ACA compliant plans. Previously, only female sterilization was

covered at 100%. This coverage change will become effective upon the 1/1/2021 renewal for the Fund.

We will be working with the Risk Manager of each member entity to determine coverage.

## ADMINISTRATIVE AUTHORIZATIONS

There is one administrative authorization for a Level II medical necessity appeal. The IRO determination upheld Aetna's denial.

Members of the public attending the Remote Public Meeting will be able to submit comments by raising their virtual hand in the Zoom meeting application or by typing in their information in the comment section of the application. The moderator of the Zoom Meeting will recognize those members of the public that wish to submit a comment and, if more than one, will establish a queue for those wishing to comment. The Chair will recognize, in order, each member of the public that desires to provide public comment. When recognized, the member of the public shall identify themselves by name, address and, if applicable, the group or organization that they represent.

Members of the public participating in a Remote Public Meeting shall conduct themselves with decorum, shall not use abusive, defamatory, or obscene language and any comments made shall be concise and to the point. The Chairperson, in his/her discretion, may interrupt, warn, or mute the individual's ability to speak if their conduct/comment is abusive, defamatory, obscene, or overly long.

## **EXECUTIVE DIRECTORS REPORT**

**FINANCIAL FAST TRACK – SCIC and SSRHIF -** as of September 2020 – Executive Director said September was a good month, with the Fund slightly under budget overall. She said we are starting to see claims return to a pre Covid level. She said the Commission fast track shows a surplus of about \$1.8 million of which about \$1.4 million is cash. She said the recommendation is to start to transfer some of that surplus over to the Fund. She said resolution 19-20 approves a transfer of \$700,000 to the SSRHIF closed years account.

## 2021 BUDGET PRESENTATION

Executive Director said the 2021 proposed budget was distributed to the Commissioners. She said overall the budget is increasing by 5.86%. She said the actuary reviewed the Fund data through August 2020 and are recommending increasing the medical claims line 6.26% and prescription by 15%. She said we do include prescription rebates which are about 20% of our prescription spend the overall rx increase is about 8.76%. She said the coresource population will be going to Aenta or UHC Medicare advantage. She said the Medicare Advantage line for the County and the library has been reduced due to the elimination of the Health Insurer fee. She said the reinsurance has not been finalized but industry wide it has been about 15%. The Health Center fee was left flat, but this will be discussed further in closed session.

Program Manager said the savings opportunities were included as part of the presentation because there are potential claims lines that would be impacted. He said for Rx they are currently investigating 2 programs offered by ESI which are SaveonSP which is a copay assistance program and the national preferred formulary. He said currently the Fund is in the basic preferred formulary, but through the national preferred formulary, ESI has targeted certain medications that are more cost efficient. He said both programs are utilized in other Funds across the state and they have produced significant savings.

Executive Director said the increase included for the Votech is the actual annual increase, it would not need to be doubled this year.

## **RFP - ONSITE HEALTH CENTER**

Executive Director said earlier this month, a subcommittee met with the professionals to review the qualifications and interview both respondents. The Committee asked for a "best and final' pricing offer, of which the Fund received this week. We will be going into closed session to discuss the results of the RFP for the onsite health center at the conclusion of the meeting. A separate zoom number has been sent to the Executive Committee.

## **RFPs - PROFESSIONAL SERVICES**

Executive Director said Requests for Proposals for the Attorney, Actuary and Auditor positions were issued in June with responses received on July 6<sup>th</sup>. She said Competing responses were received for

all positions. The subcommittee also reviewed these responses and are recommending Scholl, Whittlesey & Gruenberg LLC for Attorney and Actuarial Solutions LLC for Actuary.

The committee requested "best and final pricing" from both of the Auditors which has been included in the summary. Our recommendation is to stay with the incumbent, which is only \$360 more than the competing proposal. Resolution 18-20 appoints the Attorney, Actuary and Auditor, if the Committee approves this recommendation and is included in the consent agenda.

Program Manager said with the introduction of the budget today, they will start discussions regarding open enrollment and they will be working directly with the Risk managers. He said the over 65 population should have received their notice of credible coverage letters.

## 2021 BUDGET - INTRODUCTION

The 2021 draft budget has been included for introduction for the Southern Skylands Regional Health Insurance Fund.

Some highlights:

## Overall, the budget is increasing 5.86%.

**Claims**: The Actuary has reviewed the Commission's data through August 2020 and is recommending an overall increase of 6.26% for medical and 15% for prescription, but including prescription rebates, the overall Rx claim increase is 8.76%

The Coresource population will completely transfer to Aetna or United Healthcare Medicare Advantage. Those lives have shifted in this presentation in the claims line and administrative fee.

**Medicare Advantage and Reinsurance**: The Medicare Advantage renewals for the County and Library have reduced due to the removal of the health insurer fee in 2021.

The reinsurance has not been finalized. Industry average is about 15%, which is being reflected in this budget.

**Partnership Health Center**: This line may change subject to the results of the RFP. For illustrative purposes, this line has been left flat.

Loss Fund Contingency: There is no contingency included in this budget.

Administrative Fees and Taxes: The expenses are updated, as per RFP results.

**Savings Opportunities:** The program manager is investigation two prescription programs utilization management opportunities– SaveOn SP and the National Preferred Formulary. They will be reporting back in future meetings to discuss their recommendation(s).

- 1. *SaveOn SP-* a specialty medication copay assistance program that utilizes prescription manufacture dollars to minimize the high costs of specialty medications for the Fund and its members.
- 2. *National Preferred Formulary* Express Scripts exclusive formulary developed to steer members to the most clinically, cost efficient medications in various drug categories.

The following illustrates the billing increase by line. The claim fund increase and the assessments may vary by line due to allocation of fixed expenses.
